I. Preamble

- The present Privacy Policy is applicable to the principles and manner of collection, processing and use of information about the users of our website www.linevsystems.com
- 2. This Policy describes how LINEV Group and subsidiaries collect and process information about you when you visit any website operated by that entities ("Website") or when you otherwise provide your personal information to that entity, as described in this Policy.
- 3. We recommended that you read the document carefully in order to understand our privacy policy and the ways in which we use your personal data.

II. Information Collected

- 1. The personal information that we may collect about you broadly obtained in the following manner:
- through information voluntarily provided by you in the electronic forms available via the Service;
- through cookie files ("cookies") stored on terminal devices;
- o through collection of www server logs by the hosting operator.
- 2. You may provide such information voluntary or when you visit our websites, we may also collect certain information by automated means from your device. Specifically, the type of information we collect automatically may include information such as your IP address, device type, unique device identification numbers, browser type, broad geographic location (e.g. country or city-level location) and operating system, referring URLs, information about your visit including the URL clickstream to, through and from our Websites, download errors, number of Website visits, average time spent on the Website, length of visits to certain pages and page interaction. We collect this information automatically through the use of various technologies including through "cookies".

We also require that our third party processors who handle your personal data do the same.
- 4. We keep your personal information for no longer than is necessary for the purpose for which the information is collected and to manage our relationship with you. III. Cookies

1. Cookies are text files containing small amounts of information which are downloaded to your computer or mobile device when you visit a Website. Cookies are then sent back to the originating website on each subsequent visit, or to another website that recognizes that cookie. Cookies are useful because they allow a website to recognize a user's device. Cookies allow you to navigate between pages efficiently, remembering your preferences and generally improving the user experience.

- 2. Cookies are used for developing statistics which help us understand how the Service Users use the website, which allows us to improve its structure and content.
- 3. We use two main types of cookies: session cookies and persistent cookies. Session cookies are temporary files which are stored on the Service User's terminal device until they log out, leave the website or close the software (website browser). Persistent cookies are stored on the User's terminal device for a period specified in the cookie parameters or until they are removed by the User.
- 4. Default settings of Internet browsers usually allow the storage of cookies on the User's terminal device. Service Users may change these settings. Interest browsers can be set to delete or block cookies. Detailed information can be found in the "help" or "documentation" section of the User's Internet browser.
- 5. Limited use of cookies may affect certain functionalities available on the Service web pages.
- 6. Cookies stored on the Service User's terminal device may also be used by the advertisers and partners cooperating with the Service operator.
